

The Correspondent has submitted the application for Renewal of Recognition for the classes VIII to X (EM)in the school for the years from 2020-21 to 2029-30 through the Deputy Educational Officer, Vijayawada in the reference 7th read above.

5. That the results of institution shall be satisfactory every year
6. That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
7. That the list of Governing Body shall be furnished to the District Educational Officer every year.
8. That the pay structure/fee structure fixed by the Governing Body shall be got approved by the District Ednl. Officer every year.
9. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with
10. That the school shall not be closed without giving notice both to the parents/DEO & competent authority at least 6 months before
11. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
12. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
13. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
14. The management informed that no thatched roof accommodation is allowed to run the School.
15. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students
16. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
17. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
18. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
19. The school shall have first aid kit and the teachers shall be trained in first aid.
20. The Correspondent of the concerned school is hereby informed to file an affidavit before 30th of April every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
21. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail to the inspecting officer.
22. That the management shall ensure the Accounts of the school audited by an authorized Chartered Accountant every year and submit the same to this office along with Annual Administration Report without fail.
23. That the management has to maintain trained teachers at all time.
24. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
25. That the management is informed to obtain and submit the NOC issued by the Fire Services Dept authorities concerned from time to time without any interruption to the recognition period without fail to the Inspecting officer
26. That the management of the school is informed that, these orders are issued subject to conditions that, to obtain and submit the occupancy Clearance of fire issued by the concerned department within the stipulated dates mentioned in the order and submit to this office through the inspecting officer concerned for the entire period of recognition without fail.
